

Role title:	Explosives Safety Management Supervisor

Role purpose:

To implement, communicate, and supervise explosives safety across defined areas of responsibility, efficiently and in an environmentally sound manner using appropriate techniques which are efficient, effective and timely and in compliance with all relevant legal and other requirements. Consult Technical Authorities as appropriate.

Responsibilities of this role:

- Comply with your organisation's policies, procedures and practices.
- Contribute to the design of, and implement, a robust Safe Statement Of Work, which identifies Hazards, mitigates risks, predicts possible outcomes including unplanned events, and provides appropriate emergency procedures.
- Contribute to the development of, and implement, assurance systems for ESA safety.
- Implement the ESM audit plan to effectively and efficiently provide assurance that legal, performance and stakeholder requirements are met (SHE, Quality, scheduling, compliance)
- Communicate the plan and de-conflict where necessary.
- Monitor the plan and adjust as appropriate within level of responsibility.
- Confirm that facilities (including plant and equipment) are fit for the required ESA task; maintenance regime is up-to-date and that they are certified to carry out the planned task.
Report discrepancies and contribute to improvement.
- Confirm that resources (people, time) available to complete, safely and successfully the ESA task.
- Ensure self and others are competent with suitable training, knowledge, experience, behaviour and ability.
- Confirm the type, quantity, condition and requirement for the ESA activities.
Identify and make safety recommendations for the adaptation or design of new equipment equipment/plant, process, procedure or technique, where appropriate.
- Provide assurance of logistics, hand-over, approval, receipt and despatch processes as required.
- Ensure that explosives safety management and team leaders are made aware of ESA Safety Management issues and the need to provide appropriate direction, funding and leadership to bring about successful ESM.
- Review performance, identify and recommend or initiate improvements.
